

TERMS & CONDITIONS FOR
<Up to 34% Fuel Savings for PDVL/TDVL Drivers!> NETWORK PROMOTION

The **<Up to 34% Fuel Savings for PDVL/TDVL Drivers!>** (“**Promotion**”) is organised by Singapore Petroleum Company Limited (“**SPC**”).

Terms and Conditions applicable to this Promotion:

1. This promotion is open to all PDVL and TDVL Members (“**Participants**”), you have agreed to participate in the Promotion and accept all the Terms and Conditions of the Promotion.
2. This promotion is valid from 1 July – 30 September 2026 (both dates inclusive).
3. All Credit or Debit cards rebates and rewards are applicable with this Promotion.

Upfront Discount

4. From **1 July to 30 September 2026** (both dates inclusive), Participants will enjoy an instant **23% fuel discount** upon presenting their membership at the time of purchase.
5. This Promotion cannot be combined with other offers, discounts, promotions, unless otherwise stated.

Additional Discounts for Registered Members

6. In addition to the Upfront Discount, Participants who meet the weekly fuel purchase thresholds (Monday – Sunday), will be eligible for an additional e-coupon:
 - (a) 50 litres or more – an additional 4% e-coupon; or
 - (b) 100 litres or more – an additional 6% e-coupon.
7. To be eligible for this additional 4% or 6% e-coupons, you **must be a registered PDVL and TDVL Members**. Existing PDVL/TDVL members who have not yet registered may do so by downloading the SPC+ App and creating an account using your User ID (DDMMYYNNN) and PDVL/TDVL sticker number.
8. New PDVL/TDVL applicants are required to create an SPC+ App account via Login > Sign Up and complete the PDVL/TDVL registration and activation process to qualify for the additional 4% or 6% fuel e-coupons. For more information on SPC+ App, please visit: <https://www.spc.com.sg/spcapp/>.
9. E-coupons will be issued to qualified registered Participants by 1:00 a.m. on the Monday immediately following the week in which the applicable fuel purchase threshold is met. The final issuance of e-coupons will be on 28 September 2026.
10. Each e-coupon shall be valid only for fuel purchases made from Monday to Sunday of the week in which it is issued and shall expire at the end of that week.

Example: A Participant who purchases the qualifying minimum volume of fuel between **13 July and 19 July 2026** will receive the applicable **4% or 6% e-coupon** on **20 July 2026**. The e-coupon may be used only for fuel purchases made between **20 July and 26 July 2026** (Monday to Sunday) and will expire at the end of **26 July 2026** if unused.
